2. I understand that this application is a request, on my part, for referral through Local 322 for employment.
3. I understand that all referrals by Local 322 are conducted in accordance with the REFERRAL RULES AND REGULATIONS.
4. I have received and reviewed a copy of the REFERRAL RULES AND REGULATIONS.
5. I understand that completing this application does not guarantee employment with a Local 322 signatory employer. If employment through a signatory employer becomes available in the future, Local 322 will notify me in accordance with the REFERRAL RULES AND REGULATIONS.
6. I understand that Local 322 will make the first contact with me regarding referral. I will not call Local 322 for a work assignment prior to the first contact by Local 322.
7. I agree to pay Local 322 a referral fee equal to the sum of five percent (5%) of Gross wages earned while working in Local 322's jurisdiction. Refusal to pay The five percent (5%) fee, since said fee is reasonably related to the expense of referral, is a basis upon which Local 322 may deny me further referral. This five percent (5%) fee should be paid monthly or by check-off.
